### **Action Items:**

- 1. Approval of Minutes from April 12, 2023 and May 10, 2023 Meeting: Bob motioned, John seconded. Motion carried.

Suzanne provided an update on an ongoing Tourism Economics platform Teams call to be held monthly. All are invited to attend. A brief recap of sales activity was given. Tourism activities updated including the recent French FAM. Media press trip for UK writer with autistic child is planned for July. Reviewed current routes in Sequoia & Kings Canyon as road repairs are made were discussed. Gateway Shuttle on hold until about July 1 when Hwy 198 is scheduled to reopen to Giant Forest. City is ready to operate the Shuttle as soon as directed.

It was discussed having a PR firm help with messaging to say that the parks are currently open as there is confusion.
